



Halloween Safety

Alberta Health Services EMS would like to remind parents and trick-or-treaters of some basic Halloween safety tips, as October 31st approaches. As a member of the Calgary's Child Magazine, *Partners for Safety*; ambulances, along with Calgary police, fire, bylaw, transit, and Shaw Cable vehicles will be out patrolling communities on Halloween night, to provide a visible safety resource for parents and trick-or-treaters.

Trick-or-Treaters

- Remember: all regular pedestrian rules still apply. Be sure to cross the road at marked cross walks or well lit corners only. It is safest to work your way up one side of the street and then cross once to the other side.
- Stay away from houses that are not well lit. Do not accept rides from strangers, or enter any home you feel is unsafe.
- Let your parents know where you are going to be at all times and advise them if you will be late returning.

Parents

- Be certain that young trick-or-treaters are accompanied by an adult. Older children should stay in groups.
- Pre-determine boundaries to trick-ortreat within and establish a firm time to return home.
- Advise children not to eat anything until they return home. Dispose of any items that appear to have been tampered with, or that are not properly wrapped.

Costumes

- Choose bright colored costumes that are highly visible. Adding reflective tape to costumes further increases visibility.
- Consider sending your children with a flashlight for additional safety and increased visibility.
- When purchasing or making costumes, look for materials and accessories that are labeled flameresistant.
- All costume accessories, such as sticks, rods or wands, should be soft and flexible, with no sharp edges.
- Consider using hypoallergenic makeup kits instead of masks that may impair breathing or vision.
- Be sure costumes are loose enough to be worn over warm clothing – but not so baggy or long that they become a tripping hazard. Costumes should not be longer than your child's ankles.
- Ensure your child is wearing adequate foot wear that takes into consideration weather conditions and walking.

A Message from Alderman Druh Farrell



Rapid urban growth can put pressure on municipal budgets. Without adequate finances, cities are unable to undertake the capital improvements needed to keep up with growth, let alone maintain our existing infrastructure.

How Calgary grows and who pays for growth has been at the forefront of recent City discus-

sions. Mandated by Council in 2009, growth management (Framework for Growth and Change) is a new process that will help The City budget for the needs of new communities without burdening the existing taxpayer. In the past, the costs associated with growth were addressed on an ad hoc basis. The new Framework for Growth and Change, once approved by Council, will ensure that Calgary grows responsibly and that we reinvest in existing communities. Residents in new communities will not have to wait as long for key services and the financial risks will be covered by those who profit from development. We will also ensure free-market choice that reflects actual development costs, establishes a logical pattern of growth and eliminates subsidies currently covered by all Calgarians.

Until recently, all of our population growth occurred in new communities while we slowly lost population in older areas. We are now making our first tentative steps toward restoring populations in established neighbourhoods. The ultimate aim is for an equal split, which will be realized gradually over a 60-year period, between growth in new and existing communities. Over the next five years, 94% of the city's growth is expected to remain in the suburbs.

In the New Year, Council will make its final decision on growth management, which will deliver a more financially sustainable future for all Calgarians. If approved, it will ensure we live within our means rather than bestow a great debt on future generations.

Seth Perfect

Seth Perfect, a nine year old resident of Briar Hill, decided that he would raise some money this summer by selling popcorn and lemonade on Wednesday evenings during the soccer season. Nothing too unusual about that; except for the fact that Seth was earmarking all proceeds towards the Alberta Children's Hospital.

In 2012, Seth was diagnosed with a spinal cord tumor, and was operated on in August of that year. Recovery and rehabilitation have been a slow and difficult process for Seth.

Seth spent some time at the hospital's Gordon Townsend School and has been attending the rehabilitation clinic, as well as a variety of other appointments, during the last year.

This is a good news story; Seth is now active in school, soccer, badminton and squash, and the prognosis for the tumor is good. Even better, he raised over \$600 for his cause in a mere six evenings of fundraising.

Many thanks must go out to any child or parent who bought popcorn or lemonade, as well as to all those families kind enough to offer donations.



2013 September Flood Mitigation - Message from Alderman Druh Farrell

As post-flood life slowly returns to normal for most Calgarians, The City has started the difficult task of assessing the damage and evaluating ways to protect us all from future flooding. The early tally is stunning, and it is expected to increase as we learn more. The Roads department has repaired over a hundred sinkholes, and Water Services continues to assess damage to the storm sewer system, street by street. Almost 90km of river pathways were closed and at least half will need to be rebuilt or moved. All of our beloved parks in the river valley are now partially open, but most will require remediation that will span several years. Some, like Pierce Estate Park, and Sue Higgins Park (Southland Park), lost hectares of land to the raging river as it altered its course.

We need to rethink before we rebuild. Early estimates of \$265 million in flood recovery projects could grow to \$500 million, and this is a tally primarily for repair and replacement. Additional funds will be needed for flood mitigation to protect public infrastructure for the future. The list is long, and includes projects such as flood protection for the downtown core, Calgary's economic engine where hundreds of thousands of Calgarians work, shop, and recreate. Essential infrastructure, like our traffic signal system located in the basement of the Municipal Building, will need to be rebuilt and moved to higher ground.

This month, Council will receive updated cost estimates from City Administration and an expert flood mitigation panel. We know from the experience of other communities that have recovered from major disasters, like Slave Lake and Medicine Hat, that all costs are not covered by Provincial disaster funding or insurance. The City will be able to access rainy day funds and Provincial tax room, and we'll need to make some hard choices.

Throughout the evaluation and review process, Calgarians will be given the opportunity to share their recommendations and ideas to ensure that we make the best and most cost-effective decisions possible. The City is working to create a webpage where citizen input and suggestions can be collected and summarized for the expert panel. Once this page is operational, please provide your suggestions and ideas.

Sears gas plume update

Clifton Associates Ltd. (Clifton), on behalf of Sears Canada Inc. (Sears), is pleased to provide the following status update to the community of Hounsfield Heights.

Clifton completed the first monitoring and sampling event of 2013 as scheduled and submitted the report to Alberta Environment and Sustainable Resource Development (AESRD) in July. The remediation system located within Lions Park has continued to clean residual gasoline from the groundwater. The system is currently undergoing some maintenance and is expected to be back in operation before the end of October.

A revised Site Management Plan (SMP) was submitted to AESRD in July. The SMP has been reviewed by AESRD and their comments have been received by Clifton and Sears. AESRD's comments are being incorporated into an updated plan which will be resubmitted to AESRD for review in the near future.

As stated in the previous update, once the resubmitted SMP has been accepted, Sears and Clifton would like to invite the residents of Hounsfield Heights to an open house. There will be a public discussion regarding the SMP and the work to be completed. It is expected that the open house will be held sometime in Spring 2014.

Sears and Clifton appreciate the opportunity to provide this information to the residents of Hounsfield Heights and are looking forward to implementing the resubmitted SMP.

Fostering safe communities...

Fall is the time of year when many Calgarians are busy preparing their homes and yards for the winter months ahead. Here are some things to keep in mind during your fall cleanup:

- Under the Community Standards Bylaw, it is illegal to burn leaves and yard waste. Check calgary.ca for leaf drop off locations.
- Tree branches may be disposed of with your household garbage. All tree branch trimmings left out for waste collection must be packaged in plastic garbage bags, tied in bundles or placed in your black or green bin for collection. Bundles can be no more than 1.25 metres in length and must weigh less than 20 kg each. Bundles should be put out for collection on your regularly scheduled collection date and must be placed at least 0.3 m (1 foot) from your blue, black or green bins.
- According to the Drainage Bylaw, water from a hot tub or pool can't be drained into the storm drainage system that channels water into our rivers. Instead, this water should be drained into the wastewater drain located in the basement of your home.
- Hazardous materials such as gasoline, motor oil and paint cannot be disposed of with your household garbage. Visit calgary.ca to find a list of Throw n' Go locations and fire stations with special storage depots for proper disposal of these materials.

Licensing Your Cat or Dog

The first step towards responsible pet ownership is to license your cat or dog. Here are five things every Calgarian should know about pet licensing:

- **1. Your cat or dog's licence is his ticket home!** Licensing your pet provides Animal & Bylaw Services with the information needed to reunite you with your pet should he ever become lost. A licence tag also tells people who may find your cat or dog that the animal is owned and that they should turn him in to Animal & Bylaw Services.
- 2. Licensing your cat or dog is the law! Under the Responsible Pet Ownership Bylaw 23M2006, by three months of age, all cats and dogs residing in Calgary must be licensed with The City of Calgary Animal & Bylaw Services. The penalty for an unlicensed cat or dog is \$250.
- **3.** Cat and dog licences must be renewed annually! A one-year licence costs:
 - \$15 for altered cats and kittens (up to six months old)
 - \$30 for unaltered cats
 - \$36 for altered dogs and puppies (up to six months old)
 - \$58 for unaltered dogs
- 4. Your licence fees, not tax dollars, fund our Animal Services operations! Your fees allow us to:
 - Return lost cats and dogs to their owners and enforce the Responsible Pet Ownership Bylaw.
 - Deliver school programs and educate animal owners about responsible pet ownership.
 - Feed and shelter lost cats and dogs at the Animal Services Centre.
 - Operate a state-of-the-art veterinary clinic to provide care for adoptable cats and dogs.
 - Operate our animal adoption and volunteer animal socialization programs.
 - Provide emergency medical care for lost cats and dogs that are injured.
 - Help neighbours resolve animal-related conflicts.
 - Provide free spay or neuter surgeries for the cats and dogs of low-income Calgarians.

Graffiti Vandalism Affects Communities

A message from the Federation of Calgary Communities Building Safe Communities Program



Graffiti vandalism is figures, letters, drawings or stickers applied, scribbled, scratched, etched, sprayed or attached on or to the surface of any premises, structure, or other property. It can be done by a variety of methods including spray paint, markers, etching and pens to name a few. Graffiti done without the owner's permission is vandalism and is a crime carrying serious consequences. Most graffiti vandalism IS not gang related, but if graffiti vandalism is left unchecked, other criminal activities may begin to start in the area as the perception of the community is that no one cares or is taking care of the area. **Graffiti vandalism** is not removed quickly, this inaction may be interpreted as a sign of low neighborhood pride, and graffiti vandalism will spread to other buildings, streets and properties.

What to do:

- 1. Record the graffiti vandalism by taking a photograph (if possible) of the damage.
- 2. Note the location.
- 3. Report the graffiti by calling 311.
- 4. Remove the graffiti if it is on your property or with permission of the property owner. The longer it is left for viewing the more likely other graffiti will appear in the area.
